

Current status of the Issues of Construction Licenses and Usage Licenses

1. Taipei County

(a) Construction Licenses

577 Construction Licenses were issued in Taipei County in 2009 and compared with last year's figure, the number decreased 15.6%. The total floor area was 3,052,000 square meters, which decreased 29.8%. Among all, Housing (H-2) had 1,810,000 square meters (59.3%), Industry and Warehousing (C) had 387,000 square meters (12.7%), and Business and Service (G) had 306,000 square meters (10.0%).

9,903 units of Housing (H-2) Construction Licenses were issued in 2009, the total floor area was 1,810,000 square meters and the average area of each unit was 182.8 square meters.

(b) Usage Licenses

801 Usage Licenses were issued in Taipei County in 2009, which decreased 7.5% compared with last year's figure; the total floor area was 5,922,000 square meters (decreased 4.9%). Among all, Housing (H-2) had 4,120,000 square meters (69.6%), Business and Service (G) had 763,000 square meters (12.9%) and Industry and Warehousing (C) had 434,000 square meters (7.3%).

26,242 units of Housing (H-2) Usage Licenses were issued in 2009, the total floor area was 4,120,000 square meters and the average area of each unit was 157.0 square meters.

2. I-lan County

(a) Construction Licenses

1,246 Construction Licenses were issued in I-lan County in 2009 and compared with last year's figure, the number increased 21.8%. The total floor area was 663,000 square meters, which increased 27.3%. Among all, Housing (H-2) had 372,000 square meters (56.1%), Industry and Warehousing (C) had 124,000 square meters (18.8%), and others had 82,000 square meters (12.3%).

1,885 units of Housing (H-2) Construction Licenses were issued in 2009, the total floor area was 372,000 square meters and the average area of each unit was 197.2 square meters.

(b) Usage Licenses

1,014 Usage Licenses were issued in I-lan County in 2009, which decreased 27.3% compared with last year's figure; the total floor area was 484,000 square meters (decreased 45.4%). Among all, Housing (H-2) had 171,000 square meters

(35.4%), Industry and Warehousing (C) had 128,000 square meters (26.4%), Leisure and Education (D) had 68,000 square meters (14.1%).

1,126 units of Housing (H-2) Usage Licenses were issued in 2009, the total floor area was 171,000 square meters and the average area of each unit was 152.2 square meters.

3. Taoyuan County

(a) Construction Licenses

1,455 Construction Licenses were issued in Taoyuan County in 2009 and compared with last year's figure, the number decreased 5.5%. The total floor area was 2,074,000 square meters, which decreased 29.8%. Among all, Housing (H-2) had 963,000 square meters (46.4%), Industry and Warehousing (C) had 602,000 square meters (29.0%), Leisure and Education (D) had 228,000 square meters (11.0%).

4,700 units of Housing (H-2) Construction Licenses were issued in 2009, the total floor area was 963,000 square meters and the average area of each unit was 204.8 square meters.

(b) Usage Licenses

1,297 Usage Licenses were issued in Taoyuan County in 2009, which decreased 43.1% compared with last year's figure; the total floor area was 2,660,000 square meters (decreased 36.6%). Among all, Housing (H-2) had 1,468,000 square meters (55.2%), Industry and Warehousing (C) had 644,000 square meters (24.2%), Business and Service (G) had 177,000 square meters (6.7%).

8,287 units of Housing (H-2) Usage Licenses were issued in 2009, the total floor area was 1,468,000 square meters and the average area of each unit was 177.2 square meters.

4. Hsinchu County

(a) Construction Licenses

650 Construction Licenses were issued in Hsinchu County in 2009 and compared with last year's figure, the number decreased 17.4%. The total floor area was 860,000 square meters, which decreased 33.5%. Among all, Housing (H-2) had 604,000 square meters (70.2%), Industry and Warehousing (C) had 75,000 square meters (8.7%), Business and Service (G) had 72,000 square meters (8.4%).

2,851 units of Housing (H-2) Construction Licenses were issued in 2009, the total floor area was 604,000 square meters and the average area of each unit was 211.7 square meters.

(b) Usage Licenses

715 Usage Licenses were issued in Hsinchu County in 2009, which decreased 21.6% compared with last year's figure; the total floor area was

1,135,000 square meters (increased 0.9%). Among all, Housing (H-2) had 648,000 square meters (57.1%), Mercantile (B) had 140,000 square meters (12.4%) and others had 87,000 square meters (7.7%).

3,188 units of Housing (H-2) Usage Licenses were issued in 2009, the total floor area was 648,000 square meters and the average area of each unit was 203.1 square meters.

5. Miaoli County

(a) Construction Licenses

925 Construction Licenses were issued in Miaoli County in 2009 and compared with last year's figure, the number decreased 14.1%. The total floor area was 483,000 square meters, which decreased 24.3%. Among all, Housing (H-2) had 206,000 square meters (42.7%), Business and Service (G) had 109,000 square meters (22.6%), and Industry and Warehousing (C) had 56,000 square meters (11.6%).

1,053 units of Housing (H-2) Construction Licenses were issued in 2009, the total floor area was 206,000 square meters and the average area of each unit was 195.9 square meters.

(b) Usage Licenses

922 Usage Licenses were issued in Miaoli County in 2009, which decreased 40.7% compared with last year's figure; the total floor area was 551,000 square meters (decreased 25.2%), Among all, Housing (H-2) had 214,000 square meters (38.8%), Industry and Warehousing (C) had 102,000 square meters (18.5%) and Business and Service (G) had 89,000 square meters (16.2%).

1,125 units of Housing (H-2) Usage Licenses were issued in 2009, the total floor area was 214,000 square meters and the average area of each unit was 190.2 square meters.

6. Taichung County

(a) Construction Licenses

1,739 Construction Licenses were issued in Taichung County in 2009 and compared with last year's figure, the number increased 0.5%. The total floor area was 1,163,000 square meters, which increased 4.0%. Among all, Housing (H-2) had 608,000 square meters (52.3%), Industry and Warehousing (C) had 340,000 square meters (29.2%) and Business and Service (G) had 61,000 square meters (5.3%).

3,078 units of Housing (H-2) Construction Licenses were issued in 2009, the total floor area was 608,000 square meters and the average area of each unit was 197.6 square meters.

(b) Usage Licenses

1,358 Usage Licenses were issued in Taichung County in 2009, which decreased 42.6% compared with last year's figure ; the total floor area was

1,030,000 square meters (decreased 33.8 %). Among all, Housing (H-2) had 468,000 square meters (45.5%), Industry and Warehousing (C) had 267,000 square meters (25.9%) and Business and Service (G) had 108,000 square meters (10.4%).

2,389 units of Housing (H-2) Usage Licenses were issued in 2009, the total floor area was 468,000 square meters and the average area of each unit was 196.1 square meters

7. Changhua County

(a) Construction Licenses

1,296 Construction Licenses were issued in **Changhua** County in 2009 and compared with last year's figure, the number increased 35.1%. The total floor area was 679,000 square meters, which increased 14.9%. Among all, Housing (H-2) had 290,000 square meters (42.7%), Industry and Warehousing (C) had 234,000 square meters (34.5%), and Leisure and Education (D) had 70,000 square meters (10.3%).

1,291 units of Housing (H-2) Construction Licenses were issued in 2009, the total floor area was 290,000 square meters and the average area of each unit was 224.8 square meters.

(b) Usage Licenses

936 Usage Licenses were issued in Changhua County in 2009, which decreased 34.7% compared with last year's figure; the total floor area was 600,000 square meters (decreased 34.7%). Among all, Housing (H-2) had 249,000 square meters (41.6%), Industry and Warehousing (C) had 220,000 square meters (36.7%) and Leisure and Education (D) had 50,000 square meters (8.4%).

1,160 units of Housing (H-2) Usage Licenses were issued in 2009, the total floor area was 249,000 square meters and the average area of each unit was 215.0 square meters.

8. Nantou County

(a) Construction Licenses

536 Construction Licenses were issued in **Nantou** County in 2009 and compared with last year's figure, the number increased 3.9%. The total floor area was 169,000 square meters, which decreased 54.3%. Among all, Housing (H-2) had 70,000 square meters (41.8%), Industry and Warehousing (C) had 27,000 square meters (16.2%), and Nursing House (H-1) had 21,000 square meters (12.4%).

449 units of Housing (H-2) Construction Licenses were issued in 2009, the total floor area was 70,000 square meters and the average area of each unit was 156.8 square meters.

(b) Usage Licenses

457 Usage Licenses were issued in **Nantou** County in 2009, which decreased 37.8% compared with last year's figure; the total floor area was 424,000 square meters (increased 32.5%). Among all, Leisure and Education (D) had 150,000 square meters (35.3%), Housing (H-2) had 59,000 square meters (14.0%) and Nursing House (H-1) had 57,000 square meters (13.3%).

348 units of Housing (H-2) Usage Licenses were issued in 2009, the total floor area was 59,000 square meters and the average area of each unit was 170.7 square meters.

9. Yunlin

(a) Construction Licenses

1,028 Construction Licenses were issued in Yunlin County in 2009 and compared with last year's figure, the number increased 3.2%. The total floor area was 477,000 square meters, which decreased 21.5%. Among all, Housing (H-2) had 171,000 square meters (35.8%), others had 102,000 square meters (21.4%) and Industry and Warehousing (C) had 89,000 square meters (18.7%).

781 units of Housing (H-2) Construction Licenses were issued in 2009, the total floor area was 171,000 square meters and the average area of each unit was 218.8 square meters.

(b) Usage Licenses

883 Usage Licenses were issued in Yunlin County in 2009, which decreased 36.3% compared with last year's figure; the total floor area was 567,000 square meters (decreased 37.3%). Among all, Industry and Warehousing (C) had 203,000 square meters (35.8%), Housing (H-2) had 146,000 square meters (25.7%), and Welfare and Reviviscence (F) had 63,000 square meters (11.2%).

687 units of Housing (H-2) Usage Licenses were issued in 2009, the total floor area was 146,000 square meters and the average area of each unit was 212.0 square meters.

10. Chiayi County

(a) Construction Licenses

693 Construction Licenses were issued in Chiayi County in 2009 and compared with last year's figure, the number inceased 39.2%. The total floor area was 310,000 square meters, which increased 28.6%. Among all, Housing (H-2) had 108,000 square meters (34.8%), Industry and Warehousing (C) had 102,000 square meters (33.0%), and Leisure and Education (D) ad 49,000 square meters (15.7%)

640 units of Housing (H-2) Construction Licenses were issued in 2009, the total floor area was 108,000 square meters and the average area of each unit was 168.5 square meters.

(b) Usage Licenses

401 Usage Licenses were issued in Chiayi County in 2009, which decreased 46.5% compared with last year's figure; the total floor area was 299,000 square meters (decreased 43.6%). Among all, Housing (H-2) had 117,000 square meters (38.9%), Nursing House (H-1) had 66,000 square meters (22.1%), and Industry and Warehousing (C) had 39,000 square meters (13.0%).

370 units of Housing (H-2) Usage Licenses were issued in 2009, the total floor area was 117,000 square meters and the average area of each unit was 315.0 square meters.

11. Tainan County

(a) Construction Licenses

1,883 Construction Licenses were issued in Tainan County in 2009 and compared with last year's figure, the number decreased 13.1%. The total floor area was 782,000 square meters, which decreased 33.5%. Among all, Housing (H-2) had 342,000 square meters (43.8%), Industry and Warehousing (C) had 165,000 square meters (21.1%), and others had 140,000 square meters (18.5%).

1,665 units of Housing (H-2) Construction Licenses were issued in 2009, the total floor area was 342,000 square meters and the average area of each unit was 205.6 square meters.

(b) Usage Licenses

1,590 Usage Licenses were issued in Tainan County in 2009, which decreased 44.7% compared with last year's figure; the total floor area was 834,000 square meters (decreased 40.0%). Among all, Industry and Warehousing (C) had 303,000 square meters (36.3%), Housing (H-2) had 282,000 square meters (33.8%) and others had 96,000 square meters (11.5%).

1,449 units of Housing (H-2) Usage Licenses were issued in 2009, the total floor area was 282,000 square meters and the average area of each unit was 194.8 square meters.

12. Kaohsiung County

(a) Construction Licenses

1,663 Construction Licenses were issued in **Kaohsiung** County in 2009 and compared with last year's figure, the number increased 29.2%. The total floor area was 1,138,000 square meters, which decreased 15.4%. Among all, Housing (H-2) had 590,000 square meters (51.8%), Industry and Warehousing (C) had 268,000 square meters (23.5%), and Leisure and Education (D) had 78,000 square meters (6.9%).

3,543 units of Housing (H-2) Construction Licenses were issued in 2009, the total floor area was 590,000 square meters and the average area of each unit was 166.4 square meters.

(b) Usage Licenses

1,054 Usage Licenses were issued in **Kaohsiung** County in 2009, which decreased 54.7% compared with last year's figure; the total floor area was 1,012,000 square meters (decreased 24.8%). Among all, Housing (H-2) had 303,000 square meters (30.0%), Industry and Warehousing (C) had 185,000 square meters (18.3%) and Mercantile (B) had 171,000 square meters (16.9%).

1,442 units of Housing (H-2) Usage Licenses were issued in 2009, the total floor area was 303,000 square meters and the average area of each unit was 210.3 square meters.

13. Pingtung County

(a) Construction Licenses

1,060 Construction Licenses were issued in Pingtung County in 2009 and compared with last year's figure, the number increased 4.0%. The total floor area was 584,000 square meters, which increased 2.0%. Among all, Housing (H-2) had 227,000 square meters (38.8%), others had 176,000 (30.2%), and Industry and Warehousing (C) had 75,000 square meters (12.9%).

1,136 units of Housing (H-2) Construction Licenses were issued in 2009, the total floor area was 227,000 square meters and the average area of each unit was 199.4 square meters.

(b) Usage Licenses

857 Usage Licenses were issued in Pingtung County in 2009, which decreased 31.7% compared with last year's figure; the total floor area was 528,000 square meters (increased 1.0%). Among all, others had 182,000 square meters (34.5%), Housing (H-2) had 115,000 square meters (21.7%) and Industry and Warehousing (C) had 99,000 square meters (18.7%).

521 units of Housing (H-2) Usage Licenses were issued in 2009, the total floor area was 115,000 square meters and the average area of each unit was 220.0 square meters.

14. Taitung County

(a) Construction Licenses

419 Construction Licenses were issued in Taitung County in 2009 and compared with last year's figure, the number increased 40.1%. The total floor area was 165,000 square meters, which increased 82.6%. Among all, Housing (H-2) had 77,000 square meters (46.5%), Mercantile (B) had 45,000 square meters (27.3%), and Industry and Warehousing (C) had 21,000 square meters (13.0%).

357 units of Housing (H-2) Construction Licenses were issued in 2009, the total floor area was 77,000 square meters and the average area of each unit was 214.4 square meters.

(b) Usage Licenses

305 Usage Licenses were issued in Taitung County in 2009, which decreased 20.2% compared with last year's figure; the total floor area was 88,000 square meters (decreased 41.6%). Among all, Housing (H-2) had 51,000 square meters (58.7%), Leisure and Education (D) had 21,000 square meters (23.5%), and others had 5,000 square meters (5.2%).

254 units of Housing (H-2) Usage Licenses were issued in 2009, the total floor area was 51,000 square meters and the average area of each unit was 202.1 square meters.

15. Hualien County

(a) Construction Licenses

580 Construction Licenses were issued in Hualien County in 2009 and compared with last year's figure, the number increased 31.2%. The total floor area was 346,000 square meters, which increased 106.5%. Among all, Housing (H-2) had 115,000 square meters (33.2%), Leisure and Education (D) had 89,000 square meters (25.6%), and Nursing House (H-1) had 59,000 square meters (17.0%).

609 units of Housing (H-2) Construction Licenses were issued in 2009, the total floor area was 115,000 square meters and the average area of each unit was 188.4 square meters.

(b) Usage Licenses

441 Usage Licenses were issued in Hualien County in 2009, which decrease 27.4% compared with last year's figure; the total floor area was 271,000 square meter (increased 1.2%). Among all, Housing (H-2) had 75,000 square meters (27.7%), Mercantile (B) had 52,000 square meters (19.2%), and Health Care, Welfare and Reviviscence (F) had 42,000 square meters (15.5%)

350 units of Housing (H-2) Usage Licenses were issued in 2009, the total floor area was 75,000 square meters and the average area of each unit was 214.6 square meters.

16. Penghu County

(a) Construction Licenses

306 Construction Licenses were issued in Penghu County in 2009 and compared with last year's figure, the number increased 11.3%. The total floor area was 98,000 square meters, which decreased 40.0%. Among all, Housing (H-2) had 62,000 square meters (63.2%), Industry and Warehousing (C) had 14,000 square meters (14.4%), and Business and Service (G) had 11,000 square meters (11.7%).

250 units of Housing (H-2) Construction Licenses were issued in 2009, the total floor area was 62,000 square meters and the average area of each unit was 247.9 square meters.

(b) Usage Licenses

274 Usage Licenses were issued in Penghu County in 2009, which decreased 16.5% compared with last year's figure; the total floor area was 95,000 square meters (decreased 24.6%). Among all, Housing (H-2) had 56,000 square meters (58.7%), Mercantile (B) had 13,000 square meters (13.4%), and Leisure and Education (D) had 11,000 square meters (11.7%).

232 units of Housing (H-2) Usage Licenses were issued in 2009, the total floor area was 56,000 square meters and the average area of each unit was 240.7 square meters.

17. Keelung City

(a) Construction Licenses

86 Construction Licenses were issued in Keelung City in 2009 and compared with last year's figure, the number decreased 14.0%. The total floor area was 231,000 square meters, which decreased 8.0%. Among all, Leisure and Education (D) had 80,000 square meters (34.4%), Housing (H-2) had 79,000 square meters (34.0%), and Business and Service (G) had 42,000 square meters (18.0%)

363 units of Housing (H-2) Construction Licenses were issued in 2009, the total floor area was 79,000 square meters and the average area of each unit was 216.9 square meters.

(b) Usage Licenses

88 Usage Licenses were issued in Keelung City in 2009, which decreased 9.3% compared with last year's figure; the total floor area was 340,000 square meters (increased 3.6%). Among all, Housing (H-2) had 271,000 square meters (79.5%), Leisure and Education (D) had 43,000 square meters (12.5%), and Industry and Warehousing (C) had 15,000 square meters (4.5%).

1,747 units of Housing (H-2) Usage Licenses were issued in 2009, the total floor area was 271,000 square meters and the average area of each unit was 154.9 square meters.

18. Hsinchu City

(a) Construction Licenses

352 Construction Licenses were issued in Hsinchu City in 2009 and compared with last year's figure, the number increased 11.8%. The total floor area was 891,000 square meters, which decreased 10.9%. Among all, Housing (H-2) had 646,000 square meters (72.4%), Business and Service (G) had 143,000 square meters (16.0%), Leisure and Education (D) had 51,000 square meters (5.8%).

3,044 units of Housing (H-2) Construction Licenses were issued in 2009, the total floor area was 646,000 square meters and the average area of each unit was 212.1 square meters.

(b) Usage Licenses

298 Usage Licenses were issued in Hsinchu City in 2009, which decreased 46.3% compared with last year's figure; the total floor area was 959,000 square meters (decreased 10.5%). Among all, Housing (H-2) had 606,000 square meters (63.2%), Business and Service (G) had 168,000 square meters (17.5%), and Mercantile (B) had 45,000 square meters (4.7%).

3,022 units of Housing (H-2) Usage Licenses were issued in 2009, the total floor area was 606,000 square meters and the average area of each unit was 200.5 square meters.

19. Taichung City

(a) Construction Licenses

733 Construction Licenses were issued in Taichung City in 2009 and compared with last year's figure, the number increased 12.3%. The total floor area was 1,062,000 square meters, which decreased 51.4%. Among all, Housing (H-2) had 682,000 square meters (64.2%), Industry and Warehousing (C) had 127,000 square meters (11.9%), and Business and Service (G) had 116,000 square meters (11.0%).

2,771 units of Housing (H-2) Construction Licenses were issued in 2009, the total floor area was 682,000 square meters and the average area of each unit was 246.2 square meters.

(b) Usage Licenses

538 Usage Licenses were issued in Taichung City in 2009, which decreased 42.8% compared with last year's figure; the total floor area was 1,825,000 square meters (decreased 5.3%). Among all, Housing (H-2) had 1,316,000 square meters (72.1%), Business and Service (G) had 200,000 square meters (11.0%), and Industry and Warehousing (C) had 95,000 square meters (5.2%).

6,086 units of Housing (H-2) Usage Licenses were issued in 2009, the total floor area was 1,316,000 square meters and the average area of each unit was 216.2 square meters.

20. Chiayi City

(a) Construction Licenses

405 Construction Licenses were issued in Chiayi City in 2009 and compared with last year's figure, the number increased 27.0%. The total floor area was 191,000 square meters, which increased 10.8%. Among all, Housing (H-2)

had 100,000 square meters (52.5%), Leisure and Education (D) had 41,000 square meters (21.4%), Industry and Warehousing (C) had 22,000 square meters (11.4%).

466 units of Housing (H-2) Construction Licenses were issued in 2009, the total floor area was 100,000 square meters and the average area of each unit was 214.6 square meters.

(b) Usage Licenses

304 Usage Licenses were issued in Chaiyi City in 2009, which decreased 48.7% compared with last year's figure; the total floor area was 176,000 square meters (decreased 43.3%). Among all, Housing (H-2) had 75,000 square meters (42.7%), Others had 33,000 square meters (18.6%), and Health Care, Welfare and Reviviscence (F) had 27,000 square meters (15.6%).

349 units of Housing (H-2) Usage Licenses were issued in 2009, the total floor area was 75,000 square meters and the average area of each unit was 215.0 square meters.

21. Tainan City

(a) Construction Licenses

1,119 Construction Licenses were issued in Tainan City in 2009 and compared with last year's figure, the number increased 18.4%. The total floor area was 521,000 square meters, which decreased 13.9%. Among all, Housing (H-2) had 300,000 square meters (57.6%), Leisure and Education (D) had 83,000 square meters (16.0%) and Industry and Warehousing (C) had 53,000 square meters (10.2%).

1,326 units of Housing (H-2) Construction Licenses were issued in 2009, the total floor area was 300,000 square meters and the average area of each unit was 226.4 square meters.

(b) Usage Licenses

673 Usage Licenses were issued in Tainan City in 2009, which decreased 46.8% compared with last year's figure; the total floor area was 478,000 square meters (decreased 44.8%). Among all, Housing (H-2) had 288,000 square meters (60.2%), Industry and Warehousing (C) had 84,000 square meters (17.6%) and Leisure and Education (D) had 54,000 square meters (11.4%).

1,100 units of Housing (H-2) Usage Licenses were issued in 2009, the total floor area was 288,000 square meters and the average area of each unit was 261.9 square meters.

22. Taipei City

(a) Construction Licenses

455 Construction Licenses were issued in Taipei City in 2009 and compared with last year's figure, the number decreased 14.6%. The total floor area was

2,536,000 square meters, which decreased 10.5 %. Among all, Housing (H-2) had 1,125,000 square meters (44.3%), Mercantile (B) had 407,000 square meters (16.1%) and Business and Service (G) had 395,000 square meters (15.6%).

6,288 units of Housing (H-2) Construction Licenses were issued in 2009, the total floor area was 1,125,000 square meters and the average area of each unit was 178.9 square meters.

(b) Usage Licenses

465 Usage Licenses were issued in Taipei City in 2009, which decreased 10.4% compared with last year's figure; the total floor area was 3,322,000 square meters (decreased 5.9%). Among all, Housing (H-2) had 1,469,000 square meters (44.2%), Business and Service (G) had 604,000 square meters (18.2%) and Leisure and Education (D) had 422,000 square meters (12.7%).

9,637 units of Housing (H-2) Usage Licenses were issued in 2009, the total floor area was 1,469,000 square meters and the average area of each unit was 152.5 square meters.

23. Kaohsiung City

(a) Construction Licenses

995 Construction Licenses were issued in Kaohsiung City in 2009 and compared with last year's figure, the number increased 4.6%. The total floor area was 862,000 square meters, which decreased 38.8%. Among all, Housing (H-2) had 479,000 square meters (55.5%), Leisure and Education (D) had 101,000 square meters (11.7%), and Industry and Warehousing (C) had 100,000 square meters (11.6%).

2,334 units of Housing (H-2) Construction Licenses were issued in 2009, the total floor area was 479,000 square meters and the average area of each unit was 205.0 square meters.

(b) Usage Licenses

768 Usage Licenses were issued in Kaohsiung City in 2009, which decreased 52.9% compared with last year's figure; the total floor area was 1,265,000 square meters (decreased 39.8%). Among all, Housing (H-2) had 872,000 square meters (69.0%), Leisure and Education (D) had 116,000 square meters (9.2%), and Industry and Warehousing (C) had 103,000 square meters (8.2%).

4,244 units of Housing (H-2) Usage Licenses were issued in 2009, the total floor area was 872,000 square meters and the average area of each unit was 205.5 square meters.

24. Kinmen County

(a) Construction Licenses

184 Construction Licenses were issued in Kinmen County in 2009 and compared with last year's figure, the number increased 2.2%. The total floor area was 88,000 square meters, which decreased 35.5%. Among all, Housing (H-2) had 51,000 square meters (57.8%), Leisure and Education (D) had 19,000 square meters (21.3%) and Industry and Warehousing (C) had 8,000 square meters (9.1%).

345 units of Housing (H-2) Construction Licenses were issued in 2009, the total floor area was 51,000 square meters and the average area of each unit was 147.7 square meters.

(b) Usage Licenses

184 Usage Licenses were issued in Kinmen County in 2009, which increased 29.6% compared with last year's figure; the total floor area was 97,000 square meters (increased 22.4%). Among all, Housing (H-2) had 53,000 square meters (54.6%), Industry and Warehousing (C) had 21,000 square meters (21.8%), and Business and Service (G) had 13,000 square meters (13.2%).

421 units of Housing (H-2) Usage Licenses were issued in 2009, the total floor area was 53,000 square meters and the average area of each unit was 126.3 square meters.

25. Lienchiang County

(a) Construction Licenses

13 Construction Licenses were issued in Lienchiang County in 2009 and compared with last year's figure, the number increased 18.2%. The total floor area was 6,284 square meters, which decreased 55.6%. Among all, Business and Service (G) had 2,297 square meters (36.6%), Housing (H-2) had 2,051 square meters (32.6%) and Leisure and Education (D) had 975 square meters (15.5%).

15 units of Housing (H-2) Usage Licenses were issued in 2009, the total floor area was 2,051 square meters and the average area of each unit was 136.7 square meters.

(b) Usage Licenses

6 Usage Licenses were issued in Lienchiang County in 2009 and compared with last year's figure, the number increased 50.0%. The total floor area was 7,704 square meters, which decreased 45.0%. Among all, Leisure and Education (D) had 5,934 square meters (77.0%), Business and Service (G) had 1,548 square meters (20.1%), and others had 133 square meters (1.7%).

1 unit of Housing (H-2) Usage Licenses was issued in 2009, the total floor area was 89 square meters and the average area of each unit was 89 square meters.
