

Current status of the Issues of Construction Licenses and Usage Licenses

1. Taipei County

(a) Construction Licenses

684 Construction Licenses were issued in Taipei County in 2008 and compared with last year's figure, the number decreased 27.4%. The total floor area was 4,347,000 square meters, which decreased 28.5%. Among all, Housing (H-2) had 3,142,000 square meters (72.3%), Industry and Warehousing (C) had 517,000 square meters (11.9%), and Business and Service (G) had 318,000 square meters (7.3%).

17,614 units of Housing (H-2) Construction Licenses were issued in 2008, the total floor area was 3,142,000 square meters and the average area of each unit was 178.4 square meters.

(b) Usage Licenses

866 Usage Licenses were issued in Taipei County in 2008, which increased 7.2% compared with last year's figure; the total floor area was 6,224,000 square meters (increased 4.3%). Among all, Housing (H-2) had 4,544,000 square meters (73.0%), Business and Service (G) had 988,000 square meters (15.9%) and Industry and Warehousing (C) had 259,000 square meters (4.2%).

31,434 units of Housing (H-2) Usage Licenses were issued in 2008, the total floor area was 4,544,000 square meters and the average area of each unit was 144.6 square meters.

2. Yilan County

(a) Construction Licenses

1,023 Construction Licenses were issued in Yilan County in 2008 and compared with last year's figure, the number decreased 29.0%. The total floor area was 521,000 square meters, which decreased 22.6%. Among all, Housing (H-2) had 214,000 square meters (41.2%), Industry and Warehousing (C) had 132,000 square meters (25.3%), and Leisure and Education (D) had 42,000 square meters (8.1%).

1,150 units of Housing (H-2) Construction Licenses were issued in 2008, the total floor area was 214,000 square meters and the average area of each unit was 186.5 square meters.

(b) Usage Licenses

1,395 Usage Licenses were issued in Yilan County in 2008, which decreased 5.0% compared with last year's figure; the total floor area was 886,000 square meters (increased 46.3%). Among all, Housing (H-2) had 455,000 square meters

(51.4%), Mercantile (B) had 176,000 square meters (19.9%), Industry and Warehousing (C) had 94,000 square meters (10.6%).

2,521 units of Housing (H-2) Usage Licenses were issued in 2008, the total floor area was 455,000 square meters and the average area of each unit was 180.6 square meters.

3. Taoyuan County

(a) Construction Licenses

1,540 Construction Licenses were issued in Taoyuan County in 2008 and compared with last year's figure, the number decreased 38.7%. The total floor area was 2,954,000 square meters, which decreased 18.2%. Among all, Housing (H-2) had 1,315,000 square meters (44.5%), Industry and Warehousing (C) had 901,000 square meters (30.5%) and Business and Service (G) had 421,000 square meters (14.2%).

6,762 units of Housing (H-2) Construction Licenses were issued in 2008, the total floor area was 1,315,000 square meters and the average area of each unit was 194.5 square meters.

(b) Usage Licenses

2,281 Usage Licenses were issued in Taoyuan County in 2008, which decreased 12.0% compared with last year's figure; the total floor area was 4,198,000 square meters (decreased 17.6%). Among all, Housing (H-2) had 2,459,000 square meters (58.6%), Industry and Warehousing (C) had 1,059,000 square meters (25.2%) and Business and Service (G) had 244,000 square meters (5.8%).

15,032 units of Housing (H-2) Usage Licenses were issued in 2008, the total floor area was 2,459,000 square meters and the average area of each unit was 163.6 square meters.

4. Hsinchu County

(a) Construction Licenses

787 Construction Licenses were issued in Hsinchu County in 2008 and compared with last year's figure, the number decreased 18.1%. The total floor area was 1,292,000 square meters, which decreased 23.9%. Among all, Housing (H-2) had 748,000 square meters (57.9%), and Business and Service (G) had 276,000 square meters (21.4%), and Leisure and Education (D) had 87,000 square meters (6.7%).

3,405 units of Housing (H-2) Construction Licenses were issued in 2008, the total floor area was 748,000 square meters and the average area of each unit was 219.8 square meters.

(b) Usage Licenses

912 Usage Licenses were issued in Hsinchu County in 2008, which

decreased 24.4% compared with last year's figure; the total floor area was 1,125,000 square meters (decreased 34.7%). Among all, Housing (H-2) had 729,000 square meters (64.8%), Business and Service (G) had 205,000 square meters (18.2%) and Industry and Warehousing (C) had 79,000 square meters (7.0%).

3,772 units of Housing (H-2) Usage Licenses were issued in 2008, the total floor area was 729,000 square meters and the average area of each unit was 193.3 square meters.

5. Miaoli County

(a) Construction Licenses

1,077 Construction Licenses were issued in Miaoli County in 2008 and compared with last year's figure, the number decreased 32.7%. The total floor area was 638,000 square meters, which decreased 24.7%. Among all, Housing (H-2) had 260,000 square meters (4.08%), Business and Service (G) had 140,000 square meters (21.9%), and Industry and Warehousing (C) had 121,000 square meters (18.9%).

1,368 units of Housing (H-2) Construction Licenses were issued in 2008, the total floor area was 260,000 square meters and the average area of each unit was 190.1 square meters.

(b) Usage Licenses

1,555 Usage Licenses were issued in Miaoli County in 2008, which increased 6.7% compared with last year's figure; the total floor area was 737,000 square meters (decreased 6.7%), Among all, Housing (H-2) had 313,000 square meters (42.5%), Industry and Warehousing (C) had 164,000 square meters (22.3%) and Business and Service (G) had 99,000 square meters (13.4%).

1,927 units of Housing (H-2) Usage Licenses were issued in 2008, the total floor area was 313,000 square meters and the average area of each unit was 162.5 square meters.

6. Taichung County

(a) Construction Licenses

1,730 Construction Licenses were issued in Taichung County in 2008 and compared with last year's figure, the number decreased 38.3%. The total floor area was 1,118,000 square meters, which decreased 34.2%. Among all, Housing (H-2) had 571,000 square meters (51.1%), Industry and Warehousing (C) had 285,000 square meters (25.5%) and Business and Service (G) had 82,000 square meters (7.3%).

2,894 units of Housing (H-2) Construction Licenses were issued in 2008, the total floor area was 571,000 square meters and the average area of each unit was 197.3 square meters.

(b) Usage Licenses

2,366 Usage Licenses were issued in Taichung County in 2008, which

decreased 28.0% compared with last year's figure ; the total floor area was 1,555,000 square meters (decreased 16.3 %). Among all, Housing (H-2) had 988,000 square meters (63.6%), Industry and Warehousing (C) had 263,000 square meters (16.9%) and Leisure and Education (D) had 91,000 square meters (5.9%).

5,204 units of Housing (H-2) Usage Licenses were issued in 2008, the total floor area was 988,000 square meters and the average area of each unit was 189.9 square meters.

7. Changhua County

(a) Construction Licenses

959 Construction Licenses were issued in **Changhua** County in 2008 and compared with last year's figure, the number decreased 40.9%. The total floor area was 591,000 square meters, which decreased 33.2%. Among all, Industry and Warehousing (C) had 299,000 square meters (50.5%), Housing (H-2) had 185,000 square meters (31.3%), and Leisure and Education (D) had 37,000 square meters (6.2%).

873 units of Housing (H-2) Construction Licenses were issued in 2008, the total floor area was 185,000 square meters and the average area of each unit was 212.2 square meters.

(b) Usage Licenses

1,433 Usage Licenses were issued in Changhua County in 2008, which decreased 33.9% compared with last year's figure; the total floor area was 919,000 square meters (decreased 26.9%). Among all, Housing (H-2) had 347,000 square meters (37.7%), Industry and Warehousing (C) had 265,000 square meters (28.9%) and Business and Service (G) had 134,000 square meters (14.6%).

1,852 units of Housing (H-2) Usage Licenses were issued in 2008, the total floor area was 347,000 square meters and the average area of each unit was 187.3 square meters.

8. Nantou County

(a) Construction Licenses

516 Construction Licenses were issued in **Nantou** County in 2008 and compared with last year's figure, the number decreased 27.9%. The total floor area was 369,000 square meters, which decreased 1.4%. Among all, Leisure and Education (D) had 101,000 square meters (27.3%), Housing (H-2) had 67,000 square meters (18.2%), and Industry and Warehousing (C) had 60,000 square meters (16.2%).

415 units of Housing (H-2) Construction Licenses were issued in 2008, the total floor area was 67,000 square meters and the average area of each unit was 161.6 square meters.

(b) Usage Licenses

735 Usage Licenses were issued in **Nantou** County in 2008, which decreased 27.2% compared with last year's figure; the total floor area was

320,000 square meters (decreased 23.7%). Among all, Housing (H-2) had 126,000 square meters (39.4%), Industry and Warehousing (C) had 68,000 square meters (21.1%) and Leisure and Education (D) had 35,000 square meters (11.0%).

672 units of Housing (H-2) Usage Licenses were issued in 2008, the total floor area was 126,000 square meters and the average area of each unit was 187.6 square meters.

9. Yunlin County

(a) Construction Licenses

996 Construction Licenses were issued in Yunlin County in 2008 and compared with last year's figure, the number decreased 33.3%. The total floor area was 608,000 square meters, which decreased 23.2%. Among all, Industry and Warehousing (C) had 199,000 square meters (32.8%), Housing (H-2) had 163,000 square meters (26.8%), and Leisure and Education (D) had 50,000 square meters (8.2%).

733 units of Housing (H-2) Construction Licenses were issued in 2008, the total floor area was 163,000 square meters and the average area of each unit was 222.5 square meters.

(b) Usage Licenses

1,385 Usage Licenses were issued in Yunlin County in 2008, which decreased 14.3% compared with last year's figure; the total floor area was 905,000 square meters (decreased 1.1%). Among all, Industry and Warehousing (C) had 299,000 square meters (33.1%), Housing (H-2) had 242,000 square meters (26.7%), and Business and Service (G) had 134,000 square meters (14.8%).

1,148 units of Housing (H-2) Usage Licenses were issued in 2008, the total floor area was 242,000 square meters and the average area of each unit was 210.5 square meters.

10. Chiayi County

(a) Construction Licenses

498 Construction Licenses were issued in Chiayi County in 2008 and compared with last year's figure, the number decreased 39.5%. The total floor area was 241,000 square meters, which decreased 45.8%. Among all, Industry and Warehousing (C) had 94,000 square meters (39.2%), Housing (H-2) had 91,000 square meters (37.6%), Health Care, Welfare and Reviviscence (F) had 12,000 square meters (5.1%).

436 units of Housing (H-2) Construction Licenses were issued in 2008, the total floor area was 91,000 square meters and the average area of each unit was 207.8 square meters.

(b) Usage Licenses

750 Usage Licenses were issued in Chiayi County in 2008, which increased 1.4% compared with last year's figure; the total floor area was 530,000 square

meters (increased 34.8%). Among all, Housing (H-2) had 168,000 square meters (31.6%), Leisure and Education (D) had 134,000 square meters (25.3%), and Industry and Warehousing (C) had 132,000 square meters (24.8%).

743 units of Housing (H-2) Usage Licenses were issued in 2008, the total floor area was 168,000 square meters and the average area of each unit was 225.7 square meters.

11. Tainan County

(a) Construction Licenses

2,167 Construction Licenses were issued in Tainan County in 2008 and compared with last year's figure, the number decreased 40.5%. The total floor area was 1,176,000 square meters, which decreased 28.1%. Among all, Housing (H-2) had 414,000 square meters (35.2%), Industry and Warehousing (C) had 407,000 square meters (34.6%), and Leisure and Education (D) had 97,000 square meters (8.2%).

2,075 units of Housing (H-2) Construction Licenses were issued in 2008, the total floor area was 414,000 square meters and the average area of each unit was 199.4 square meters.

(b) Usage Licenses

2,874 Usage Licenses were issued in Tainan County in 2008, which decreased 16.5% compared with last year's figure; the total floor area was 1,392,000 square meters (decreased 1.5%). Among all, Housing (H-2) had 523,000 square meters (37.6%), Industry and Warehousing (C) had 410,000 square meters (29.5%) and Leisure and Education (D) had 94,000 square meters (6.8%).

2,654 units of Housing (H-2) Usage Licenses were issued in 2008, the total floor area was 523,000 square meters and the average area of each unit was 197.0 square meters.

12. Kaoshiung County

(a) Construction Licenses

1,287 Construction Licenses were issued in **Kaoshiung** County in 2008 and compared with last year's figure, the number decreased 58.1%. The total floor area was 1,345,000 square meters, which decreased 20.2%. Among all, Housing (H-2) had 808,000 square meters (60.0%), Industry and Warehousing (C) had

195,000 square meters (14.5%), and Leisure and Education (D) had 114,000 square meters (8.5%).

3,722 units of Housing (H-2) Construction Licenses were issued in 2008, the total floor area was 808,000 square meters and the average area of each unit was 217.0 square meters.

(b) Usage Licenses

2,327 Usage Licenses were issued in **Kaoshiung** County in 2008, which decreased 17.4% compared with last year's figure; the total floor area was 1,345,000 square meters (decreased 8.2%). Among all, Housing (H-2) had 795,000 square meters (59.1%), Industry and Warehousing (C) had 304,000 square meters (22.6%) and Leisure and Education (D) had 85,000 square meters (6.3%).

3,905 units of Housing (H-2) Usage Licenses were issued in 2008, the total floor area was 795,000 square meters and the average area of each unit was 203.5 square meters.

13. Pingtung County

(a) Construction Licenses

1,019 Construction Licenses were issued in Pingtung County in 2008 and compared with last year's figure, the number decreased 39.7%. The total floor area was 573,000 square meters, which decreased 23.3%. Among all, Housing (H-2) had 311,000 square meters (54.3%), Industry and Warehousing (C) had 123,000 square meters (21.5%), and Health Care, Welfare and Reviviscence (F) had 26,000 square meters (4.6%).

1,287 units of Housing (H-2) Construction Licenses were issued in 2008, the total floor area was 311,000 square meters and the average area of each unit was 241.8 square meters.

(b) Usage Licenses

1,254 Usage Licenses were issued in Pingtung County in 2008, which decreased 26.9% compared with last year's figure; the total floor area was 523,000 square meters (decreased 28.1%). Among all, Housing (H-2) had 279,000 square meters (53.4%), Industry and Warehousing (C) had 76,000 square meters (14.5%) and Leisure and Education (D) had 47,000 square meters (9.1%).

1,102 units of Housing (H-2) Usage Licenses were issued in 2008, the total floor area was 279,000 square meters and the average area of each unit was 253.3

square meters.

14. Taitung County

(a) Construction Licenses

299 Construction Licenses were issued in Taitung County in 2008 and compared with last year's figure, the number decreased 29.3%. The total floor area was 900,000 square meters, which decreased 23.6%. Among all, Housing (H-2) had 52,000 square meters (57.6%), Nursing House (H-1) had 17,000 square meters (18.4%), and Business and Service (G) had 5,329 square meters (5.9%).

251 units of Housing (H-2) Construction Licenses were issued in 2008, the total floor area was 52,000 square meters and the average area of each unit was 206.6 square meters.

(b) Usage Licenses

382 Usage Licenses were issued in Taitung County in 2008, which decreased 26.8% compared with last year's figure; the total floor area was 150,000 square meters (decreased 28.3%). Among all, Housing (H-2) had 71,000 square meters (47.5%), Mercantile (B) had 26,000 square meters (17.1%), and Business and Service (G) had 16,000 square meters (10.5%).

329 units of Housing (H-2) Usage Licenses were issued in 2008, the total floor area was 71,000 square meters and the average area of each unit was 216.5 square meters.

15. Hualien County

(a) Construction Licenses

442 Construction Licenses were issued in Hualien County in 2008 and compared with last year's figure, the number decreased 34.3%. The total floor area was 167,000 square meters, which decreased 49.7%. Among all, Housing (H-2) had 76,000 square meters (45.4%), Industry and Warehousing (C) had 31,000 square meters (18.5%), and Leisure and Education (D) had 22,000 square meters (13.3%).

374 units of Housing (H-2) Construction Licenses were issued in 2008, the total floor area was 76,000 square meters and the average area of each unit was 203.4 square meters.

(b) Usage Licenses

607 Usage Licenses were issued in Hualien County in 2008, which decrease 45.6% compared with last year's figure; the total floor area was 268,000 square meter (decreased 37.5%). Among all, Housing (H-2) had 120,000 square meters (44.8%), Leisure and Education (D) had 56,000 square meters (21.0%), and Industry and Warehousing (C) had 35,000 square meters (13.1%)

572 units of Housing (H-2) Usage Licenses were issued in 2008, the total floor area was 120,000 square meters and the average area of each unit was 209.7 square meters.

16. Penghu County**(a) Construction Licenses**

275 Construction Licenses were issued in Penghu County in 2008 and compared with last year's figure, the number decreased 22.1%. The total floor area was 163,000 square meters, which increased 6.9%. Among all, Mercantile (B) had 88,000 square meters (53.8%), Housing (H-2) had 55,000 square meters (33.7%), and Leisure and Education (D) had 10,000 square meters (5.9%).

241 units of Housing (H-2) Construction Licenses were issued in 2008, the total floor area was 55,000 square meters and the average area of each unit was 228.2 square meters.

(b) Usage Licenses

328 Usage Licenses were issued in Penghu County in 2008, which increased 2.8% compared with last year's figure; the total floor area was 126,000 square meters (decreased 1.8%). Among all, Housing (H-2) had 62,000 square meters (49.2%), Mercantile (B) had 24,000 square meters (19.0%), and Leisure and Education (D) had 16,000 square meters (12.8%).

274 units of Housing (H-2) Usage Licenses were issued in 2008, the total floor area was 62,000 square meters and the average area of each unit was 226.5 square meters.

17. Keelung City

(a) Construction Licenses

100 Construction Licenses were issued in Keelung City in 2008 and compared with last year's figure, the number decreased 1.0%. The total floor area was 251,000 square meters, which decreased 14.4%. Among all, Housing (H-2) had 182,000 square meters (72.4%), Leisure and Education (D) had 29,000 square meters (11.6%), and Industry and Warehousing (C) had 11,000 square meters (4.3%)

1,041 units of Housing (H-2) Construction Licenses were issued in 2008, the total floor area was 182,000 square meters and the average area of each unit was 174.8 square meters.

(b) Usage Licenses

97 Usage Licenses were issued in Keelung City in 2008, which decreased 7.6% compared with last year's figure; the total floor area was 329,000 square meters (increased 4.2%). Among all, Housing (H-2) had 234,000 square meters (71.3%), Business and Service (G) had 60,000 square meters (18.2%), and Leisure and Education (D) had 19,000 square meters (5.8%).

1,583 units of Housing (H-2) Usage Licenses were issued in 2008, the total floor area was 234,000 square meters and the average area of each unit was 148 square meters.

18. Hsinchu City

(a) Construction Licenses

315 Construction Licenses were issued in Hsinchu City in 2008 and compared with last year's figure, the number decreased 32.0%. The total floor area was 1,000,000 square meters, which decreased 9.5%. Among all, Housing (H-2) had 748,000 square meters (74.8%), Leisure and Education (D) had 114,000 square meters (11.4%), Mercantile (B) had 45,000 square meters (4.5%).

3,857 units of Housing (H-2) Construction Licenses were issued in 2008, the total floor area was 748,000 square meters and the average area of each unit was 193.8 square meters.

(b) Usage Licenses

555 Usage Licenses were issued in Hsinchu City in 2008, which increased 20.1% compared with last year's figure; the total floor area was 1,071,000 square meters (increased 21.0%). Among all, Housing (H-2) had 627,000 square meters

(58.6%), Business and Service (G) had 313,000 square meters (29.2%), and Leisure and Education (D) had 45,000 square meters (4.2%).

3,866 units of Housing (H-2) Usage Licenses were issued in 2008, the total floor area was 627,000 square meters and the average area of each unit was 162.3 square meters.

19. Taichung City

(a) Construction Licenses

653 Construction Licenses were issued in Taichung City in 2008 and compared with last year's figure, the number decreased 36.7%. The total floor area was 2,185,000 square meters, which decreased 23.1%. Among all, Housing (H-2) had 1,431,000 square meters (65.5%), Mercantile (B) had 198,000 square meters (9.0%), and Business and Service (G) had 190,000 square meters (8.7%).

5,729 units of Housing (H-2) Construction Licenses were issued in 2008, the total floor area was 1,431,000 square meters and the average area of each unit was 249.8 square meters.

(b) Usage Licenses

940 Usage Licenses were issued in Taichung City in 2008, which decreased 24.4% compared with last year's figure; the total floor area was 1,926,000 square meters (decreased 23.6%). Among all, Housing (H-2) had 1,405,000 square meters (72.9%), Leisure and Education (D) had 171,000 square meters (8.9%), and Industry and Warehousing (C) had 151,000 square meters (7.8%).

7,731 units of Housing (H-2) Usage Licenses were issued in 2008, the total floor area was 1,405,000 square meters and the average area of each unit was 181.7 square meters.

20. Chiayi City

(a) Construction Licenses

319 Construction Licenses were issued in Chiayi City in 2008 and compared with last year's figure, the number decreased 45.6%. The total floor area was 172,000 square meters, which decreased 46.0%. Among all, Housing (H-2) had 69,000 square meters (40.4%), Public Meeting (A) had 30,000 square meters (17.5%), Leisure and Education (D) had 25,000 square meters (14.7%).

355 units of Housing (H-2) Construction Licenses were issued in 2008, the total floor area was 69,000 square meters and the average area of each unit was 195.8 square meters.

(b) Usage Licenses

592 Usage Licenses were issued in Chaoyi City in 2008, which decreased 34.4% compared with last year's figure; the total floor area was 309,000 square meters (decreased 22.4%). Among all, Housing (H-2) had 137,000 square meters (44.2%), Mercantile (B) had 65,000 square meters (20.9%), and Leisure and Education (D) had 57,000 square meters (18.5%).

633 units of Housing (H-2) Usage Licenses were issued in 2008, the total floor area was 137,000 square meters and the average area of each unit was 216.2 square meters.

21. Tainan City

(a) Construction Licenses

945 Construction Licenses were issued in Tainan City in 2008 and compared with last year's figure, the number decreased 37.0%. The total floor area was 605,000 square meters, which decreased 18.0%. Among all, Housing (H-2) had 311,000 square meters (51.3%), Industry and Warehousing (C) had 131,000 square meters (21.6%) and Leisure and Education (D) had 42,000 square meters (7.0%).

1,252 units of Housing (H-2) Construction Licenses were issued in 2008, the total floor area was 311,000 square meters and the average area of each unit was 248.2 square meters.

(b) Usage Licenses

1,264 Usage Licenses were issued in Tainan City in 2008, which decreased 39.9% compared with last year's figure; the total floor area was 867,000 square meters (decreased 39.4%). Among all, Housing (H-2) had 538,000 square meters (62%), Industry and Warehousing (C) had 138,000 square meters (15.9%) and Leisure and Education (D) had 104,000 square meters (12%).

2,843 units of Housing (H-2) Usage Licenses were issued in 2008, the total floor area was 538,000 square meters and the average area of each unit was 189.1 square meters.

22. Taipei City

(a) Construction Licenses

533 Construction Licenses were issued in Taipei City in 2008 and compared with last year's figure, the number decreased 13.9%. The total floor area was 2,833,000 square meters, which decreased 25.5 %. Among all, Housing (H-2) had 1,746,000 square meters (61.6%), Business and Service (G) had 416,000 square meters (14.7%) and Industry and Warehousing (C) had 154,000 square meters (5.4%).

9,318 units of Housing (H-2) Construction Licenses were issued in 2008, the total floor area was 1,746,000 square meters and the average area of each unit was 187.4 square meters.

(b) Usage Licenses

519 Usage Licenses were issued in Taipei City in 2008, which decreased 3.9% compared with last year's figure; the total floor area was 3,531,000 square meters (increased 17.6%). Among all, Housing (H-2) had 1,897,000 square meters (53.7%), Business and Service (G) had 630,000 square meters (17.82%) and Industry and Warehousing (C) had 337,000 square meters (9.6%).

14,169 units of Housing (H-2) Usage Licenses were issued in 2008, the total floor area was 1,897,000 square meters and the average area of each unit was 133.9 square meters.

23. Kaoshiung City**(a) Construction Licenses**

951 Construction Licenses were issued in Kaoshiung City in 2008 and compared with last year's figure, the number decreased 57.0%. The total floor area was 1,409,000 square meters, which decreased 26.9%.. Among all, Housing (H-2) had 864,000 square meters (61.4%), Business and Service (G) had 145,000 square meters (10.3%), and Industry and Warehousing (C) had 141,000 square meters (10.0%).

4,280 units of Housing (H-2) Construction Licenses were issued in 2008, the total floor area was 864,000 square meters and the average area of each unit was 202.0 square meters.

(b) Usage Licenses

1,632 Usage Licenses were issued in Kaoshiung City in 2008, which decreased 42.0% compared with last year's figure; the total floor area was 2,099,000 square meters (increased 0.8%). Among all, Housing (H-2) had 1,276,000 square meters (60.8%), Lesiure and Education (D) had 217,000 square

meters (10.3%), and Business and Service (G) had 167,000 square meters (7.9%).

6,833 units of Housing (H-2) Usage Licenses were issued in 2008, the total floor area was 1,276,000 square meters and the average area of each unit was 186.8 square meters.

24. Kinmen County

(a) Construction Licenses

180 Construction Licenses were issued in Kinmen County in 2008 and compared with last year's figure, the number decreased 14.7%. The total floor area was 137,000 square meters, which increased 23.8%. Among all, Housing (H-2) had 67,000 square meters (48.8%), Industry and Warehousing (C) had 16,000 square meters (11.7%) and Nursing House (H-1) had 8,740 square meters (6.4%).

431 units of Housing (H-2) Construction Licenses were issued in 2008, the total floor area was 67,000 square meters and the average area of each unit was 154.6 square meters.

(b) Usage Licenses

142 Usage Licenses were issued in Kinmen County in 2008, which increased 6.0% compared with last year's figure; the total floor area was 80,000 square meters (increased 29.9%). Among all, Housing (H-2) had 49,000 square meters (61.0%), Leisure and Education (D) had 14,000 square meters (17.4%), and Health Care, Welfare and Reviviscence (F) had 8,298 square meters (10.4%).

277 units of Housing (H-2) Usage Licenses were issued in 2008, the total floor area was 49,000 square meters and the average area of each unit was 175.1 square meters.

25. Lienchiang County

(a) Construction Licenses

11 Construction Licenses were issued in Lienchiang County in 2008 and compared with last year's figure, the number increased 37.5%. The total floor area was 14,144 square meters, which increased 76.1%. Among all, Health Care, Welfare and Reviviscence (F) had 8,329 square meters (58.9%), Business and Service (G) had 2,867 square meters (20.3%) and Housing (H-2) had 1,798 square meters (12.7%)..

(b) Usage Licenses

4 Usage Licenses were issued in Lienchiang County in 2008 and compared with last year's figure, the number decreased 42.9%. The total floor area was 14,000 square meters, which increased 120.8%. Among all, Leisure and Education (D) had 11,333 square meters (81.0%), Business and Service (G) had 1,819 square meters (13.0%), Mercantile (B) had 848 square meters (6.1%)
