

Current status of the Issues of Construction Licenses and Usage Licenses

1. Taipei County

(a) Construction Licenses

646 Construction Licenses were issued in Taipei County in 2010 and compared with last year's figure, the number increased 12.0%. The total floor area was 3,390,000 square meters, which increased 11.1%. Among all, Housing (H-2) had 2,408,000 square meters (71.0%), Industry and Warehousing (C) had 354,000 square meters (10.4%), and Business and Service (G) had 286,000 square meters (8.4%).

13,314 units of Housing (H-2) Construction Licenses were issued in 2010, the total floor area was 2,408,000 square meters and the average area of each unit was 180.8 square meters.

(b) Usage Licenses

560 Usage Licenses were issued in Taipei County in 2010, which decreased 30.1% compared with last year's figure; the total floor area was 4,146,000 square meters (decreased 30.0%). Among all, Housing (H-2) had 3,271,000 square meters (78.9%), Industry and Warehousing (C) had 342,000 square meters (8.3%) and Business and Service (G) had 268,000 square meters (6.5%).

19,325 units of Housing (H-2) Usage Licenses were issued in 2010, the total floor area was 3,271,000 square meters and the average area of each unit was 169.3 square meters.

2. Yilan County

(a) Construction Licenses

1,639 Construction Licenses were issued in Yilan County in 2010 and compared with last year's figure, the number increased 31.5%. The total floor area was 629,000 square meters, which decreased 5.0%. Among all, Housing (H-2) had 308,000 square meters (48.9%), Industry and Warehousing (C) had 186,000 square meters (29.6%), and Leisure and Education (D) had 72,000 square meters (11.4%).

2,023 units of Housing (H-2) Construction Licenses were issued in 2010, the total floor area was 308,000 square meters and the average area of each unit was 152.1 square meters.

(b) Usage Licenses

1,339 Usage Licenses were issued in Yilan County in 2010, which increased 32.1% compared with last year's figure; the total floor area was 411,000 square meters (decreased 15.2%). Among all, Housing (H-2) had 213,000 square meters (51.9%), Industry and Warehousing (C) had 61,000 square meters (14.8%), Leisure and Education

(D) had 43,000 square meters (10.6%).

1,363 units of Housing (H-2) Usage Licenses were issued in 2010, the total floor area was 213,000 square meters and the average area of each unit was 156.4 square meters.

3. Taoyuan County

(a) Construction Licenses

1,946 Construction Licenses were issued in Taoyuan County in 2010 and compared with last year's figure, the number increased 33.8%. The total floor area was 3,667,000 square meters, which increased 76.8%. Among all, Housing (H-2) had 1,836,000 square meters (50.1%), Industry and Warehousing (C) had 1,188,000 square meters (32.4%), Business and Service (G) had 305,000 square meters (8.3%).

9,578 units of Housing (H-2) Construction Licenses were issued in 2010, the total floor area was 1,836,000 square meters and the average area of each unit was 191.7 square meters.

(b) Usage Licenses

1,476 Usage Licenses were issued in Taoyuan County in 2010, which increased 13.8% compared with last year's figure; the total floor area was 2,243,000 square meters (decreased 15.7%). Among all, Housing (H-2) had 1,035,000 square meters (46.2%), Industry and Warehousing (C) had 663,000 square meters (29.6%), Business and Service (G) had 299,000 square meters (13.3%).

5,358 units of Housing (H-2) Usage Licenses were issued in 2010, the total floor area was 1,035,000 square meters and the average area of each unit was 193.3 square meters.

4. Hsinchu County

(a) Construction Licenses

989 Construction Licenses were issued in Hsinchu County in 2010 and compared with last year's figure, the number increased 52.2%. The total floor area was 2,128,000 square meters, which increased 147.5%. Among all, Housing (H-2) had 1,621,000 square meters (76.2%), Industry and Warehousing (C) had 369,000 square meters (17.3%), Business and Service (G) had 45,000 square meters (2.1%).

7,236 units of Housing (H-2) Construction Licenses were issued in 2010, the total floor area was 1,621,000 square meters and the average area of each unit was 224.0 square meters.

(b) Usage Licenses

626 Usage Licenses were issued in Hsinchu County in 2010, which decreased 12.5% compared with last year's figure; the total floor area was 1,020,000 square meters (decreased 10.1%). Among all, Housing (H-2) had 617,000 square meters (60.5%), Business and Service (G) had 90,000 square meters (8.9%) and Industry and Warehousing (C) had 84,000 square meters (8.3%).

2,821 units of Housing (H-2) Usage Licenses were issued in 2010, the total floor area was 617,000 square meters and the average area of each unit was 218.7 square meters.

5. Miaoli County

(a) Construction Licenses

1,338 Construction Licenses were issued in Miaoli County in 2010 and compared with last year's figure, the number increased 44.7%. The total floor area was 726,000 square meters, which increased 50.4%. Among all, Housing (H-2) had 375,000 square meters (51.6%), Leisure and Education (D) had 117,000 square meters (16.2%), and Business and Service (G) had 92,000 square meters (12.6%).

2,044 units of Housing (H-2) Construction Licenses were issued in 2010, the total floor area was 375,000 square meters and the average area of each unit was 183.3 square meters.

(b) Usage Licenses

986 Usage Licenses were issued in Miaoli County in 2010, which increased 6.9% compared with last year's figure; the total floor area was 462,000 square meters (decreased 16.2%), Among all, Housing (H-2) had 235,000 square meters (51.0%), Business and Service (G) had 102,000 square meters (22.2%) and Industry and Warehousing (C) had 47,000 square meters (10.2%).

1,251 units of Housing (H-2) Usage Licenses were issued in 2010, the total floor area was 235,000 square meters and the average area of each unit was 188.2 square meters.

6. Taichung County

(a) Construction Licenses

2,780 Construction Licenses were issued in Taichung County in 2010 and compared with last year's figure, the number increased 59.9%. The total floor area was 2,044,000 square meters, which increased 75.8%. Among all, Housing (H-2) had 1,063,000 square meters (52.0%), Industry and Warehousing (C) had 500,000 square meters (24.5%) and Mercantile (B) had 127,000 square meters (6.2%).

5,249 units of Housing (H-2) Construction Licenses were issued in 2010, the total

floor area was 1,063,000 square meters and the average area of each unit was 202.5 square meters.

(b) Usage Licenses

2,075 Usage Licenses were issued in Taichung County in 2010, which increased 52.8% compared with last year's figure; the total floor area was 1,302,000 square meters (increased 26.4 %). Among all, Housing (H-2) had 768,000 square meters (59.0%), Industry and Warehousing (C) had 329,000 square meters (25.3%) and Business and Service (G) had 72,000 square meters (5.6%).

3,867 units of Housing (H-2) Usage Licenses were issued in 2010, the total floor area was 768,000 square meters and the average area of each unit was 198.7 square meters.

7. Changhua County

(a) Construction Licenses

1,630 Construction Licenses were issued in Changhua County in 2010 and compared with last year's figure, the number increased 25.8%. The total floor area was 1,109,000 square meters, which increased 63.3%. Among all, Industry and Warehousing (C) had 446,000 square meters (40.2%), Housing (H-2) had 422,000 square meters (38.1%), and Leisure and Education (D) had 53,000 square meters (4.8%).

1, 980 units of Housing (H-2) Construction Licenses were issued in 2010, the total floor area was 422,000 square meters and the average area of each unit was 213.3 square meters.

(b) Usage Licenses

1,231 Usage Licenses were issued in Changhua County in 2010, which increased 31.5% compared with last year's figure; the total floor area was 595,000 square meters (decreased 0.9%). Among all, Housing (H-2) had 233,000 square meters (39.2%), Industry and Warehousing (C) had 195,000 square meters (32.7%) and Leisure and Education (D) had 52,000 square meters (8.7%).

1,146 units of Housing (H-2) Usage Licenses were issued in 2010, the total floor area was 233,000 square meters and the average area of each unit was 203.6 square meters.

8. Nantou County

(a) Construction Licenses

1,234 Construction Licenses were issued in Nantou County in 2010 and compared with last year's figure, the number increased 130.2%. The total floor area was 360,000

square meters, which increased 113.6%. Among all, Housing (H-2) had 179,000 square meters (49.6%), Industry and Warehousing (C) had 41,000 square meters (11.4%), and Leisure and Education (D) had 26,000 square meters (7.2%).

1,167 units of Housing (H-2) Construction Licenses were issued in 2010, the total floor area was 179,000 square meters and the average area of each unit was 153.0 square meters.

(b) Usage Licenses

962 Usage Licenses were issued in Nantou County in 2010, which increased 110.5% compared with last year's figure; the total floor area was 269,000 square meters (decreased 36.5%). Among all, Housing (H-2) had 131,000 square meters (48.5%), Nursing House (H-1) had 36,000 square meters (13.5%) and Leisure and Education (D) had 25,000 square meters (9.2%).

905 units of Housing (H-2) Usage Licenses were issued in 2010, the total floor area was 131,000 square meters and the average area of each unit was 144.4 square meters.

9. Yunlin County

(a) Construction Licenses

1,429 Construction Licenses were issued in Yunlin County in 2010 and compared with last year's figure, the number increased 39.0%. The total floor area was 777,000 square meters, which increased 62.9%. Among all, Housing (H-2) had 302,000 square meters (38.9%), Industry and Warehousing (C) had 257,000 square meters (33.1%) and Business and Service (G) had 56,000 square meters (7.2%).

1,370 units of Housing (H-2) Construction Licenses were issued in 2010, the total floor area was 302,000 square meters and the average area of each unit was 220.3 square meters.

(b) Usage Licenses

996 Usage Licenses were issued in Yunlin County in 2010, which increased 12.8% compared with last year's figure; the total floor area was 518,000 square meters (decreased 8.7%). Among all, Housing (H-2) had 171,000 square meters (33.0%), Industry and Warehousing (C) had 118,000 square meters (22.8%), and Business and Service (G) had 40,000 square meters (7.7%).

813 units of Housing (H-2) Usage Licenses were issued in 2010, the total floor area was 171,000 square meters and the average area of each unit was 210.0 square meters.

10. Chiayi County

(a) Construction Licenses

1,021 Construction Licenses were issued in Chiayi County in 2010 and compared with last year's figure, the number increased 47.3%. The total floor area was 444,000 square meters, which increased 43.4%. Among all, Housing (H-2) had 169,000 square meters (38.0%), Industry and Warehousing (C) had 155,000 square meters (34.9%), and Leisure and Education (D) had 39,000 square meters (8.7%)

1,120 units of Housing (H-2) Construction Licenses were issued in 2010, the total floor area was 169,000 square meters and the average area of each unit was 150.6 square meters.

(b) Usage Licenses

714 Usage Licenses were issued in Chiayi County in 2010, which increased 78.1% compared with last year's figure; the total floor area was 317,000 square meters (increased 5.9%). Among all, Housing (H-2) had 130,000 square meters (41.0%), Industry and Warehousing (C) had 47,000 square meters (14.8%), and Leisure and Education (D) had 11,000 square meters (3.5%).

733 units of Housing (H-2) Usage Licenses were issued in 2010, the total floor area was 130,000 square meters and the average area of each unit was 177.4 square meters.

11. Tainan County

(a) Construction Licenses

3,669 Construction Licenses were issued in Tainan County in 2010 and compared with last year's figure, the number increased 94.9%. The total floor area was 1,330,000 square meters, which increased 70.1%. Among all, Housing (H-2) had 668,000 square meters (50.2%), Industry and Warehousing (C) had 333,000 square meters (25.0%), and Leisure and Education (D) had 61,000 square meters (4.6%).

3,394 units of Housing (H-2) Construction Licenses were issued in 2010, the total floor area was 668,000 square meters and the average area of each unit was 196.9 square meters.

(b) Usage Licenses

2,295 Usage Licenses were issued in Tainan County in 2010, which increased 44.3% compared with last year's figure; the total floor area was 1,091,000 square meters (increased 30.7%). Among all, Housing (H-2) had 565,000 square meters (51.8%), Industry and Warehousing (C) had 210,000 square meters (19.3%) and Leisure and Education (D) had 59,000 square meters (5.4%).

2,937 units of Housing (H-2) Usage Licenses were issued in 2010, the total floor area was 565,000 square meters and the average area of each unit was 192.3 square meters.

12. Kaohsiung County

(a) Construction Licenses

2,140 Construction Licenses were issued in Kaohsiung County in 2010 and compared with last year's figure, the number increased 28.7%. The total floor area was 1,761,000 square meters, which decreased 54.8%. Among all, Housing (H-2) had 813,000 square meters (46.2%), Industry and Warehousing (C) had 401,000 square meters (22.8%), and Public Assembly (A) had 144,000 square meters (8.2%).

4,402 units of Housing (H-2) Construction Licenses were issued in 2010, the total floor area was 813,000 square meters and the average area of each unit was 184.8 square meters.

(b) Usage Licenses

1, 893 Usage Licenses were issued in Kaohsiung County in 2010, which increased 79.6% compared with last year's figure; the total floor area was 1,440,000 square meters (increased 42.3%). Among all, Housing (H-2) had 637,000 square meters (44.2%), Industry and Warehousing (C) had 238,000 square meters (16.5%) and Leisure and Education (D) had 65,000 square meters (4.5%).

3,563 units of Housing (H-2) Usage Licenses were issued in 2010, the total floor area was 637,000 square meters and the average area of each unit was 178.7 square meters.

13. Pingtung County

(a) Construction Licenses

1,510 Construction Licenses were issued in Pingtung County in 2010 and compared with last year's figure, the number increased 42.5%. The total floor area was 552,000 square meters, which decreased 5.5%. Among all, Housing (H-2) had 275,000 square meters (49.9%), Leisure and Education (D) had 62,000 (11.2%), and Industry and Warehousing (C) had 48,000 square meters (8.7%).

1,698 units of Housing (H-2) Construction Licenses were issued in 2010, the total floor area was 275,000 square meters and the average area of each unit was 162.1 square meters.

(b) Usage Licenses

1,130 Usage Licenses were issued in Pingtung County in 2010, which increased 31.9% compared with last year's figure; the total floor area was 442,000 square meters (decreased 16.3%). Among all, Housing (H-2) had 193,000 square meters (43.7%),

Industry and Warehousing (C) had 86,000 square meters (19.4%) and Leisure and Education (D) had 16,000 square meters (3.6%).

1,115 units of Housing (H-2) Usage Licenses were issued in 2010, the total floor area was 193,000 square meters and the average area of each unit was 173.2 square meters.

14. Taitung County

(a) Construction Licenses

515 Construction Licenses were issued in Taitung County in 2010 and compared with last year's figure, the number increased 22.9%. The total floor area was 253,000 square meters, which increased 53.7%. Among all, Housing (H-2) had 96,000 square meters (37.9%), Leisure and Education (D) had 93,000 square meters (36.9%), and Mercantile (B) had 40,000 square meters (15.8%).

512 units of Housing (H-2) Construction Licenses were issued in 2010, the total floor area was 96,000 square meters and the average area of each unit was 187.2 square meters.

(b) Usage Licenses

401 Usage Licenses were issued in Taitung County in 2010, which increased 31.5% compared with last year's figure; the total floor area was 127,000 square meters (increased 45.0%). Among all, Housing (H-2) had 80,000 square meters (63.3%), Mercantile (B) had 20,000 square meters (15.6%), and Business and Service (G) had 9,000 square meters (7.3%).

417 units of Housing (H-2) Usage Licenses were issued in 2010, the total floor area was 80,000 square meters and the average area of each unit was 192.7 square meters.

15. Hualien County

(a) Construction Licenses

746 Construction Licenses were issued in Hualien County in 2010 and compared with last year's figure, the number increased 28.6%. The total floor area was 328,000 square meters, which decreased 5.1%. Among all, Housing (H-2) had 152,000 square meters (46.4%), Leisure and Education (D) had 62,000 square meters (19.0%), and Mercantile (B) had 54,000 square meters (16.5%).

730 units of Housing (H-2) Construction Licenses were issued in 2010, the total floor area was 152,000 square meters and the average area of each unit was 208.4 square meters.

(b) Usage Licenses

517 Usage Licenses were issued in Hualien County in 2010, which increase 17.2% compared with last year's figure; the total floor area was 208,000 square meter (decreased 23.2%). Among all, Housing (H-2) had 110,000 square meters (52.7%), Business and Service (G) had 24,000 square meters (11.4%), and Mercantile (B) had 23,000 square meters (10.9%)

504 units of Housing (H-2) Usage Licenses were issued in 2010, the total floor area was 110,000 square meters and the average area of each unit was 217.5 square meters.

16. Penghu County

(a) Construction Licenses

296 Construction Licenses were issued in Penghu County in 2010 and compared with last year's figure, the number decreased 3.3%. The total floor area was 111,000 square meters, which increased 12.8%. Among all, Housing (H-2) had 52,000 square meters (47.0%), Leisure and Education (D) had 17,000 square meters (15.5%), and Business and Service (G) had 14,000 square meters (12.3%).

229 units of Housing (H-2) Construction Licenses were issued in 2010, the total floor area was 52,000 square meters and the average area of each unit was 227.2 square meters.

(b) Usage Licenses

273 Usage Licenses were issued in Penghu County in 2010, which decreased 0.4% compared with last year's figure; the total floor area was 118,000 square meters (increased 24.3%). Among all, Housing (H-2) had 59,000 square meters (49.7%), Leisure and Education (D) had 37,000 square meters (31.6%), and Mercantile (B) had 14,000 square meters (11.6%).

238 units of Housing (H-2) Usage Licenses were issued in 2010, the total floor area was 59,000 square meters and the average area of each unit was 246.9 square meters.

17. Keelung City

(a) Construction Licenses

92 Construction Licenses were issued in Keelung City in 2010 and compared with last year's figure, the number increased 7.0%. The total floor area was 258,000 square meters, which increased 11.6%. Among all, Housing (H-2) had 128,000 square meters (49.8%), Leisure and Education (D) had 51,000 square meters (19.9%), and Industry and Warehousing (C) had 40,000 square meters (15.5%)

703 units of Housing (H-2) Construction Licenses were issued in 2010, the total floor area was 128,000 square meters and the average area of each unit was 182.7 square meters.

(b) Usage Licenses

87 Usage Licenses were issued in Keelung City in 2010, which decreased 1.1% compared with last year's figure; the total floor area was 134,000 square meters (decreased 60.5%). Among all, Housing (H-2) had 46,000 square meters (34.3%), Leisure and Education (D) had 27,000 square meters (19.8%), and Industry and Warehousing (C) had 22,000 square meters (16.2%).

303 units of Housing (H-2) Usage Licenses were issued in 2010, the total floor area was 46,000 square meters and the average area of each unit was 152.1 square meters.

18. Hsinchu City

(a) Construction Licenses

345 Construction Licenses were issued in Hsinchu City in 2010 and compared with last year's figure, the number decreased 2.0%. The total floor area was 547,000 square meters, which decreased 38.6%. Among all, Housing (H-2) had 457,000 square meters (83.6%), Leisure and Education (D) had 33,000 square meters (6.0%), Business and Service (G) had 31,000 square meters (5.7%).

2,214 units of Housing (H-2) Construction Licenses were issued in 2010, the total floor area was 457,000 square meters and the average area of each unit was 206.6 square meters.

(b) Usage Licenses

281 Usage Licenses were issued in Hsinchu City in 2010, which decreased 5.7% compared with last year's figure; the total floor area was 522,000 square meters (decreased 45.6%). Among all, Housing (H-2) had 327,000 square meters (62.7%), Industry and Warehousing (C) had 69,000 square meters (13.2%), and Leisure and Education (D) had 32,000 square meters (6.2%).

1,638 units of Housing (H-2) Usage Licenses were issued in 2010, the total floor area was 327,000 square meters and the average area of each unit was 199.9 square meters.

19. Taichung City

(a) Construction Licenses

1,131 Construction Licenses were issued in Taichung City in 2010 and compared with last year's figure, the number increased 54.3%. The total floor area was 2,439,000 square meters, which increased 129.6%. Among all, Housing (H-2) had 1,731,000 square meters (71.0%), Leisure and Education (D) had 184,000 square meters (7.6%), and Industry and Warehousing (C) had 167,000 square meters (6.9%).

7,455 units of Housing (H-2) Construction Licenses were issued in 2010, the total floor area was 1,731,000 square meters and the average area of each unit was 232.2 square meters.

(b) Usage Licenses

700 Usage Licenses were issued in Taichung City in 2010, which increased 30.1% compared with last year's figure; the total floor area was 2,095,000 square meters (increased 14.8%). Among all, Housing (H-2) had 1,519,000 square meters (72.5%), Business and Service (G) had 316,000 square meters (15.1%), and Leisure and Education (D) had 84,000 square meters (4.0%).

7,309 units of Housing (H-2) Usage Licenses were issued in 2010, the total floor area was 1,519,000 square meters and the average area of each unit was 207.9 square meters.

20. Chiayi City

(a) Construction Licenses

780 Construction Licenses were issued in Chiayi City in 2010 and compared with last year's figure, the number increased 92.6%. The total floor area was 283,000 square meters, which increased 48.6%. Among all, Housing (H-2) had 197,000 square meters (69.5%), Leisure and Education (D) had 39,000 square meters (13.9%), and Nursing House (H-1) had 20,000 square meters (6.9%).

985 units of Housing (H-2) Construction Licenses were issued in 2010, the total floor area was 197,000 square meters and the average area of each unit was 199.7 square meters.

(b) Usage Licenses

366 Usage Licenses were issued in Chiayi City in 2010, which increased 20.4% compared with last year's figure; the total floor area was 163,000 square meters (decreased 6.9%). Among all, Housing (H-2) had 87,000 square meters (53.5%), Leisure and Education (D) had 32,000 square meters (19.4%), and Health Care, Welfare and Reviviscence (F) had 15,000 square meters (9.1%).

411 units of Housing (H-2) Usage Licenses were issued in 2010, the total floor area was 87,000 square meters and the average area of each unit was 212.6 square meters.

21. Tainan City

(a) Construction Licenses

1,525 Construction Licenses were issued in Tainan City in 2010 and compared with last year's figure, the number increased 36.3%. The total floor area was 1,121,000 square

meters, which increased 115.1%. Among all, Housing (H-2) had 703,000 square meters (62.7%), Industry and Warehousing (C) had 140,000 square meters (12.5%) and Leisure and Education (D) had 103,000 square meters (9.2%).

3,042 units of Housing (H-2) Construction Licenses were issued in 2010, the total floor area was 703,000 square meters and the average area of each unit was 231.1 square meters.

(b) Usage Licenses

1,493 Usage Licenses were issued in Tainan City in 2010, which increased 121.8% compared with last year's figure; the total floor area was 745,000 square meters (increased 55.7%). Among all, Housing (H-2) had 540,000 square meters (75.2%), Health Care, Welfare and Reviviscence (F) had 67,000 square meters (9.0%) and Industry and Warehousing (C) had 52,000 square meters (6.9%).

2,798 units of Housing (H-2) Usage Licenses were issued in 2010, the total floor area was 540,000 square meters and the average area of each unit was 192.9 square meters.

22. Taipei City

(a) Construction Licenses

418 Construction Licenses were issued in Taipei City in 2010 and compared with last year's figure, the number decreased 8.1%. The total floor area was 3,520,000 square meters, which increased 38.8%. Among all, Housing (H-2) had 1,383,000 square meters (39.3%), Business and Service (G) had 1,122,000 square meters (31.9%) and Mercantile (B) had 402,000 square meters (11.4%).

6,843 units of Housing (H-2) Construction Licenses were issued in 2010, the total floor area was 1,383,000 square meters and the average area of each unit was 202.0 square meters.

(b) Usage Licenses

397 Usage Licenses were issued in Taipei City in 2010, which decreased 14.6% compared with last year's figure; the total floor area was 2,462,000 square meters (decreased 25.9%). Among all, Housing (H-2) had 1,452,000 square meters (59.0%), Business and Service (G) had 438,000 square meters (17.8%) and Mercantile (B) had 184,000 square meters (7.5%).

8,244 units of Housing (H-2) Usage Licenses were issued in 2010, the total floor area was 1,452,000 square meters and the average area of each unit was 176.1 square meters.

23. Kaohsiung City

(a) Construction Licenses

1,523 Construction Licenses were issued in Kaohsiung City in 2010 and compared with last year's figure, the number increased 53.1%. The total floor area was 1,772,000 square meters, which increased 105.5%. Among all, Housing (H-2) had 1,309,000 square meters (73.9%), Business and Service (G) had 132,000 square meters (7.5%), and Industry and Warehousing (C) had 88,000 square meters (4.9%).

6,734 units of Housing (H-2) Construction Licenses were issued in 2010, the total floor area was 1,309,000 square meters and the average area of each unit was 194.4 square meters.

(b) Usage Licenses

1,145 Usage Licenses were issued in Kaohsiung City in 2010, which increased 49.1% compared with last year's figure; the total floor area was 1,357,000 square meters (increased 7.3%). Among all, Housing (H-2) had 807,000 square meters (59.5%), Business and Service (G) had 159,000 square meters (11.7%), and Mercantile (B) had 127,000 square meters (9.4%).

4,316 units of Housing (H-2) Usage Licenses were issued in 2010, the total floor area was 807,000 square meters and the average area of each unit was 187.1 square meters.

24. Kinmen County

(a) Construction Licenses

168 Construction Licenses were issued in Kinmen County in 2010 and compared with last year's figure, the number decreased 8.7%. The total floor area was 105,000 square meters, which increased 19.0%. Among all, Housing (H-2) had 66,000 square meters (63.2%), Business and Service (G) had 10,000 square meters (9.9%) and Industry and Warehousing (C) had 6,000 square meters (5.9%).

434 units of Housing (H-2) Construction Licenses were issued in 2010, the total floor area was 66,000 square meters and the average area of each unit was 152.8 square meters.

(b) Usage Licenses

217 Usage Licenses were issued in Kinmen County in 2010, which increased 17.9% compared with last year's figure; the total floor area was 133,000 square meters (increased 36.4%). Among all, Housing (H-2) had 77,000 square meters (58.1%), Leisure

and Education (D) had 12,000 square meters (9.4%), and Industry and Warehousing (C) had 2,000 square meters (1.7%).

453 units of Housing (H-2) Usage Licenses were issued in 2010, the total floor area was 77,000 square meters and the average area of each unit was 170.3 square meters.

25. Lienchiang County

(a) Construction Licenses

5 Construction Licenses were issued in Lienchiang County in 2010 and compared with last year's figure, the number decreased 61.5%. The total floor area was 2,035 square meters, which decreased 67.6%. Among all, Business and Service (G) had 579 square meters (28.5%), Housing (H-2) had 531 square meters (26.1%) and Leisure and Education (D) had 501 square meters (24.6%).

6 units of Housing (H-2) Usage Licenses were issued in 2010, the total floor area was 531 square meters and the average area of each unit was 88.5 square meters.

(b) Usage Licenses

8 Usage Licenses were issued in Lienchiang County in 2010 and compared with last year's figure, the number increased 33.3%. The total floor area was 10,070 square meters, which increased 30.7%. Among all, Health Care, Welfare and Reviviscence (F) had 6,903 square meters (68.6%), Housing (H-2) had 2,147 square meters (21.3%), and Business and Service (G) had 750 square meters (7.4%).

6 units of Housing (H-2) Usage Licenses were issued in 2010, the total floor area was 2,147 square meters and the average area of each unit was 357.8 square meters.
